### **Australian Breaking Selection Committee (ABSC) Mandate**

**Amended: 13/5/2023**

This document once approved by the executive committee of AUSBreaking will confirm and authorise the creation of the Australian Breaking Selection Committee hereafter referred to as the ABSC.

#### **Role of the ABSC**

##### **Chief responsibilities:**

1. Regulation of the selection of Australian delegates of all registered breakers (bgirls and bboys) and/or coaches (breaking experts) in Australia.
2. To put forth a selection of breakers and/or coaches to represent Australia or their local state before an event that includes a breaking competition in Australia and/or worldwide based on criteria set forth by AUSBreaking.
3. All selections are subject to final confirmation by the AUSBreaking executive committee with the ABSC to regulate and carry out the outcomes once confirmed.

Members of the ABSC include: Lowe Napalan, Youngkwang Joung, Anthony Luis Lawang, Edmundo Loayza, Lucas Marie, Don Napalan and Narumi Asada

#### **Authority of the ABSC**

With regards to the nomination of breakers and/or coaches for Australian delegates, the ABSC has the authority to select the Australian delegates upon confirmation from the AUSBreaking executive committee of national or statewide representation for breaking events in Australia and worldwide. The ABSC will maintain a transparent process for determining the delegates accessible to the public i.e. summary of candidate information considered.

Potential candidates will be considered via criteria set forth by AUSBreaking, eligible candidates will be nominated and put forth and subject to final approval from the AUSBreaking executive committee. Once approved or reclassified by the executive committee, the ABSC will confirm and present the opportunity to the selected candidates.



## **Rules, limitations and amendments**

AUSBreaking executive committee have approved initial rules and guidelines at the creation of the ABSC outlined in documents detailing the criteria related to selecting Australian delegates. Any amendments or changes to these rules are to be raised first at AUSBreaking general meetings by any AUSBreaking board member. The proposed amendment or change will be either approved or denied through majority vote held during the same AUSBreaking general meeting or rescheduled.

## **Arbitration**

In the event a member of AUSBreaking or Australian breaking community or general public raise an issue:

- Complaint or
- Contest a ruling/decision by the ABSC or AUSBreaking executive committee with regards to the selection of Australian delegates

The first point of contact in the process of arbitration will be the ABSC itself. Wherein the ABSC must address the issue within fourteen (14) days of it being received, should the ABSC and the party who raised the issue not reach an agreed solution the ABSC will forward the issue onto the AUSBreaking executive committee. The executive committee will then make a ruling through majority vote within fourteen (14) days of notification and the ABSC will carry out the decision and any changes to the selections as a result. Once an issue has been decided upon and ruled it cannot be appealed unless new evidence has emerged or circumstances involving the issue have changed enough to warrant the ABSC to reopen the issue; this is at the discretion of the ABSC.
